Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The garment was available in a size range which conformed to the manufacturer's size range, rather than the requirements of EN 14605, EN 13034, EN ISO 13982-1, EN 1073-2, and EN 1149-5, which refer to EN 340, which in its latest version (2003) refers to EN 13402. In the opinion of BTTG Testing & Certification, this size range fulfils the requirements of Annex II, Clause 1.3.1 of Directive 89/686/EEC.
- The 3MTM 4565 Protective Coverall meets the requirements of EN 1073-2:2002 except for the Puncture Resistance of the fabric, which meets Class 1 rather than Class 2 as required by the standard. The end user must decide on the basis of a risk assessment whether the resistance to puncture of the garment is acceptable.
- The User Information has been assessed in the English language only. It is the responsibility of the Manufacturer / Authorised Representative to ensure the content and accuracy of the User Information presented in other languages.
